

Vaccinations – New Health Risk?

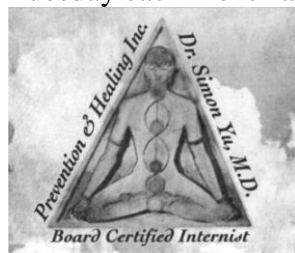

Representative Roy Holand, MD, has introduced a bill in the Missouri House of Representatives (HB852 Immunizations and Dental Services) to ban mercury in vaccines and dental restorations in Missouri. Unfortunately, the part to ban mercury in dental restorations was taken out of the bill. The bill, as of this writing, is called the House Committee Substitute for HB852 and states that "...all or any immunizations administered in the state of Missouri shall not contain any mercury or other preservatives containing heavy metals..."
